By submitting this form, you agree to the following terms:

## 1. Registration Process

1.1 To register for sponsorship, the Sponsor must complete the online registration form and submit any required documentation.

## 2. Sponsorship Benefits

- 2.1 Upon acceptance, the Sponsor will receive the benefits outlined in the sponsorship package selected during registration for all of calendar year 2025.

# 3. Payment Terms

# 4. Cancellation and Refund Policy

4.1 The Sponsor may cancel their sponsorship by providing written notice to VRNation. 4.2 Refunds will not be provided, except as specified in Section 5.2 of this Agreement.

#### 5. Termination

- 5.1 Sponsor may terminate the Agreement for cause (i) if VRNation breaches the Agreement, or (ii) in the event of VRNation's, or any of its officers', employees', agents' or affiliates' willful misconduct, violation of any law, rule or regulation, action or inaction which may damage Sponsor's reputation, or material modification to any benefits without Sponsor's prior written consent.

## **6. Use of Intellectual Property**

- 6.6 The sponsor understands that they may be captured in photographs or recordings and such media may be used by VRNation for future marketing purposes.

#### 7. Liability and Indemnification

7.1 To the maximum extent permitted by applicable law, in no event shall either party be liable under any legal theory for (i) any indirect, special, exemplary, consequential, lost profits or punitive damages arising out of or related to the Agreement or the sponsorship, including, without limitation, damages for interruption of business, even if such party has been advised of the possibility of

such damages, or (ii) any damages arising out of or related to the Agreement or the sponsorship except to the extent of actual, direct damages incurred by the other party, not to exceed \$25,000.00. The existence of multiple claims shall not increase this limit.

#### 8. Vendor Code of Ethics

- 8.1 The Sponsor agrees to adhere to VRNation's Vendor Code of Ethics, which includes but is not limited to:

- 8.2 VRNation reserves the right to terminate this Agreement immediately if the Sponsor is found to be in violation of the Vendor Code of Ethics.
- 8.3 The Sponsor agrees to promptly report any violations or suspected violations of the Vendor Code of Ethics to VRNation.

#### 9. Acceptance
